

## Florida's Gaming Bill is Off and Running!

January 9, 2012 (Tallahassee, FL)—Senate Bill 710, the bill to bring three destination casino resorts to Florida, passed through the Senate Regulated Industries committee in Tallahassee on Monday. By a 7-3 vote, the committee agreed to move the bill to its next committee of reference in the Senate.

Senator Bogdanoff overhauled her bill in a strike-all amendment and the legislation would now allow existing pari-mutuels to expand their gaming operations to include banked card games and slots, *provided local voters pass separate referendums allowing slots and the expanded gaming.* 

An equally important revision would now include the *regulation rather than ban of internet sweepstakes cafes*. The bill would **grandfather any existing internet cafes but prohibit the expansion of any new such businesses in the future**. It is estimated there are approximately 1000 internet cafes currently operating in Florida.

Sen. Charlie Dean also added an amendment that would **reduce the tax rate on slots for pari-mutuels from 35% to 10% if voters pass a referendum allowing slots.** So far, only Broward and Miami Dade have passed a referendum but other counties are now considering doing it.

As I mentioned in earlier INSIDER UPDATEs, there are currently 17 dormant parimutuel permits that may be activated at any time given the right circumstances. The new bill language will **revoke those permits and prohibit the issuance of any new parimutuel permits in the future.** 

What's next?

The bill must still go through the Budget committee <u>and</u> the Senate Rules committee which is chaired by *Senator Thrasher who voted against the bill*. The House has not discussed the bill so far, but a workshop is scheduled to hear the companion bill in the Business and Consumer Affairs committee on Wednesday.
